Since completing fellowship training, I have had the opportunity to work with various patient groups in direct care and consultation, including acute psychiatric conditions, brain injury and neurology patients, Massachusetts Dept. of Mental Health patients, patients with primary conditions in anxiety disorders, OCD, and associated movement disorders, primary rehabilitation patients, and geriatric patients. In addition, since 1994, I have provided psychiatric forensic consultation to attorneys and courts in Massachusetts and other states, both on a private basis and as a designated forensic professional for the Massachusetts Dept. of Mental Health Forensic Division. In this context, I have developed areas of expertise/interest in medical psychiatry, neuropsychiatry, psychopharmacology, geriatric psychiatry, and forensic psychiatry. My clinical and academic focus has involved different aspects of forensic psychiatry, in the forms of teaching, writing, and research projects. These areas have included the relationship of capacity/competency and cognition, the relationship of forensic psychiatry and neuropsychiatry, risk management and patient safety, geriatric forensic psychiatry, and teaching/consultation re – forensic mental health application to law enforcement, security and defense at the federal level.
